### **PURPOSE/ACTION REQUESTED**

Consider a resolution awarding the CSAH 22 (TH 112 Turnback) Improvement Project to S.M. Hentges & Sons, Inc.

#### **SUMMARY**

A bid opening for the CSAH 22 (TH 112 Turnback) Improvement was held on February 27, 2020 in Le Center at the Government Center. Two bids were submitted for the project ranging between \$15,219,084.72 and \$18,499,604.68. The low bid was submitted by S.M. Hentges & Sons, Inc. for a total approximately 11% above the engineer's estimate. The bid overage breaks down as approximately 27% City and 73% County contribution.

This brings the City's portion of the project construction cost to approximately \$5,029,460.01. Based on the final bid amount, design engineering, and proposed construction administration costs, the City's projected total project cost still falls within the budgeted amount.

On March 3, 2020, the Le Sueur County Board approved award of the bid to S.M. Hentges & Sons, Inc. contingent on approval by the Le Sueur City Council.

If approved, work is anticipated to start in May 2020 and with final completion by October 1, 2021.

Bids were received and opened at the Office of the Le Sueur County Auditor on Thursday, February 27<sup>th</sup> at 11:00am for the project referenced above. Two (2) bids were received and the results of the bids are tabulated below:

Bidder	Bid Amount
S.M. Hentges & Sons, Inc.	\$15,219,084.72
Northland Grading & Excavating, LLC	\$18,499,604.68

Engineer's Estimate \$13,656,466.95

The low bidder for the project is S.M. Hentges & Sons, Inc. from Jordan, Minnesota. The low bid is approximately 11% above the Engineer's Estimate and the next lowest bid is approximately 22% over the low bid.

Based on past performance on similar projects in previous years, it is our opinion that S.M. Hentges & Sons, Inc. is qualified to perform the work required under this contract. If deemed financially feasible, we hereby recommend that S.M. Hentges & Sons, Inc. be awarded the contract based on the bid contract amount of \$15,219,084.72. The County Board approved the award of the contract at the March 3<sup>rd</sup> Board Meeting contingent on City approval.

Hentges & Son, Inc. of Jordan, MN for the improvements of Elmwood Avenue from County Road 115 (356th St) to Ferry Street; Ferry Street from Elmwood Avenue to S 4th Street; S 4th Street from Ferry Street to Bridge Street; Bridge Street from S 4th Street to N Main; Commerce Street from Market Street to Trunk Highway 169 north bound ramp, and County State Aid Highway 26 (Ferry St) from Elmwood Avenue to County State Aid Highway 35 (Kingsway Dr), and County State Aid Highway 36 (S 2nd St) from Ferry St to Bridge St according to the plans and specifications therefor approved by the City Council and on file in the office of the City Clerk.
