PURPOSE

Consider approving the application from the Le Sueur Lions Club to adopt Jo Eagle Anderson Park.

SUMMARY

The City of Le Sueur has an Adopt-a-Park Program that allows groups to adopt a park in the City of Le Sueur. Jo Eagle Anderson Park is one of two remaining parks that are not adopted: the other being Mayo Park.

If approved by City Council, the Le Sueur Lions Club will be required to:

1. Schedule monthly litter pick-up outings, including arranging to obtain trash bags from the Public Works Department at 220 Peck Street and confirming pick-up of filled trash bags by department staff
2. Prepare and maintain flowerbeds (including planting, watering, and weeding)

ACTION REQUESTED

Staff is recommending approving the application made by the Le Sueur Lions Club to officially adopt Jo Eagle Anderson Park as part of the City of Le Sueur Adopt-a-Park Program.
