Approve the non-enclosed premises license for the Le Sueur Chamber of Commerce/Giant Celebration committee.



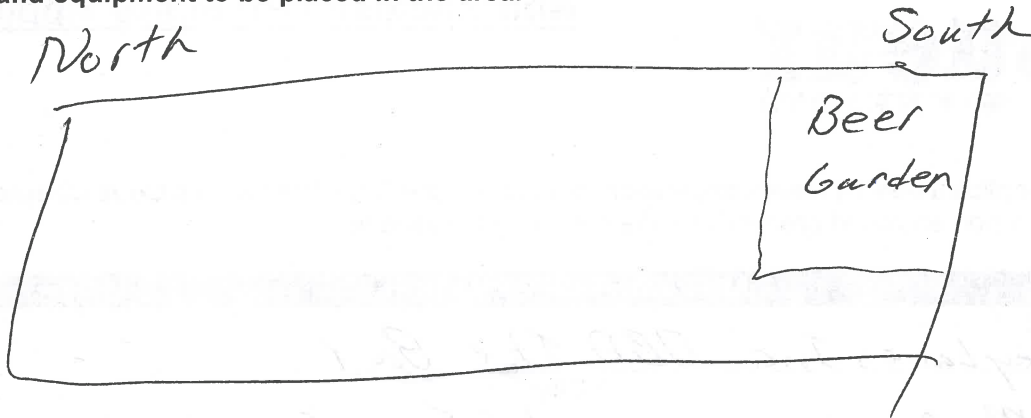
