

By participating in the We Save program, you can save energy and earn a rebate when you purchase a new furnace with a factory installed Electronically Commutated Motor (ECM) or retrofit an existing furnace with a new ECM.

### What rebate can I earn?

New Furnace with Factory Installed ECM = \$100  
New Retrofit ECM added to Existing Furnace = \$50

### What is an ECM?

An ECM is a high efficiency brushless permanent magnet motor that is electronically controlled to operate over a broad range of speeds, encompassing both constant torque and constant airflow designs.

In addition to using less energy than conventional PSC (permanent split capacitor) motors, ECMs are quieter and maintain more consistent indoor temperatures.

ENERGY STAR certified furnaces must be equipped with an ECM.

### How Do I Qualify?

- Residential customers receiving electric service from the City of Le Sueur are eligible for a rebate when they purchase a new furnace with a factory installed ECM or retrofit an existing furnace with a new ECM.
- **For factory installed ECM on new furnace, equipment must be listed on the AHRI website and a copy of AHRI Certificate attached to rebate application.** AHRI Certificate must indicate ECM.
- Information on rebate application must match invoice.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Rebate applications must include complete contractor and equipment information, copy of AHRI Certificate (for factory-installed ECM), and a copy of dated invoice including manufacturer, model, and/or serial number. Incomplete rebate applications will not be processed.
- Rebates are limited to one rebate per customer account per year.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2019.
