City Administrator Rick Almich, Le Sueur Public Library Director Dianne Pinney, Northland Securities Vice President Monte Eastvold, Park and Recreation Director Layne Wilbright, Police Chief Bruce Kelly, Electric Utility Director Greg Drent, and several area residents were also present.

A motion by Council Member Vortherms, seconded by Council Member Spinler approving the Minutes of the Regular Meeting of February 8, 2010. Voting in favor: Council Members LaBelle, Spinler, Vortherms, Kerkow, and Mayor Oberle. Voting no: None. Motion carried.

Mr. Keith Peck approached the Council on behalf of the concerned residents of Pumpkin Hill regarding the Minnesota Municipal Power Agency (MMPA) Biopower Facility. Some discussion followed.
