A motion by Council Member LaBelle, seconded by Council Member Spinler approving the Minutes of the Regular Meeting of June 22, 2009. Voting in favor: Council Members LaBelle, Spinler, Kerkow, Broeder, Vortherms, Wicks, and Mayor Oberle. Voting no: None. Motion carried.
