DATE: For the City Council Meeting of Monday, January 5th, 2026

PURPOSE

Designate the official newspaper of the City of Le Sueur for the year 2026.

SUMMARY

Le Sueur City Code Chapter 12 dictates that the City Council “shall annually designate a legal newspaper as provided by the laws of Minnesota as its official means of publication”. In 2025, the Henderson Independent was designated as the City’s official newspaper.

Minnesota State Statute 331A.04 sets a prioritization guide for cities to use when designating a qualified newspaper to serve as “official publisher”. The priority is as follows:

1. If more than one newspaper maintains a known office within the city, one must be selected;
2. If no newspaper has a primary office in the city, but one or more have a secondary office in the city, one must be selected;
3. If no qualified newspaper has a primary or secondary office within the city, a qualified newspaper “of general circulation” within the city shall be designated.

There are no qualified newspapers with primary or secondary offices within the City of Le Sueur and, as such, Council may select a newspaper using Item 3 above; namely, a newspaper that maintains a “general circulation” within Le Sueur.

It is the recommendation of City staff that the Henderson Independent remain the official publication of record for the City in 2026.

ACTION REQUESTED

Staff recommend City Council consider adoption of Resolution R2026-003, designating the Henderson Independent as official newspaper for the year 2026.

1. The Henderson Independent meets the requirements to be designated as the official newspaper for the City of Le Sueur and it will be used as the medium for all official and legal publications for the City of Le Sueur through December 2026.

PURPOSE

Appoint an Assistant Weed Inspector for the City of Le Sueur.

SUMMARY

Minnesota Noxious Weed Law dictates that the mayor of each Minnesota city shall become the designated local weed inspector for their political subdivision when they take their oath of office. The role of the local weed inspector (LWI) is to enforce the state's Noxious Weed Law, with duties spelled out in Minnesota State Statute 18.81. Specifically:

M.S. 18.81. Subdivision 2. Local weed inspectors. Local weed inspectors shall:

- (1) examine all lands, including highways, roads, alleys, and public ground in the territory over which their jurisdiction extends to ascertain if section 18.78 and related rules have been complied with;*
- (2) see that the control or eradication of noxious weeds is carried out in accordance with section 18.83 and related rules; and*
- (3) issue permits in accordance with section 18.82 and related rules for the transportation of materials or equipment infested with noxious weed propagating parts.*

Furthermore, Minnesota law allows a municipality to appoint one or more assistants to act on behalf of the mayor as a weed inspector for the municipality. Given the scope and experience of the City's Public Works & Facilities Department, the Council has previously appointed the Public Works & Facilities Manager to serve as Assistant Weed Inspector.

ACTION REQUESTED

The City Administrator is recommending the appointment of Public Works Manager Joel Schmidt and/or his delegate(s) as the City of Le Sueur Assistant Weed Inspector for 2026.

PURPOSE

Annually, various City Council positions and board/commission appointments are made by the Mayor.

SUMMARY

City Code Section 32.60 (f) Powers and Duties of the Mayor states that “the Mayor will establish all City Council committees both standing and ad hoc and appoint the members of said committees.”

All Boards and Commissions are advisory to the City Council except those administering functions jointly with other political subdivisions (City Code Section 33.001). There is currently one such body, and that is the Minnesota River Valley Transit (MRVT) Board.

Positions on the following boards/commissions may be filled by appointment of non-councilmembers:

- Minnesota Municipal Power Agency (MMPA)
- Coalition of Greater Minnesota Cities (CGMC)
- Region 9 Development Commission

There are two new committee assignments in 2026, as the Le Sueur Chamber of Commerce is seeking representation from the City in the Chamber. It is recommended that two City elected officials be assigned. While it is anticipated that the Highway 169 Corridor Coalition will disband in early 2026, it is advised that the City assign councilmembers to participate in the dissolution.
