SUBJECT: 2021 City Council Board and Commission Appointments Update

PURPOSE

SUMMARY

City Code Section 32.60 (f) Powers and Duties of the Mayor indicates that “the Mayor will establish all City Council committees both standing and ad hoc and appoint the members of said committees.”

All Boards and Commissions are advisory to the City Council except those except those administering functions jointly with other political subdivisions (City Code Section 33.001). There is one and that is currently MRVT.

The amended appointments to the Planning Commission and Region 9 Development Commission can be made by the Mayor. The appointment to the Recreation and Parks Advisory Committee is to be “appointed annually by the Mayor with the consent of the City Council.”
