### General Insurance Coverage

Required by the Minnesota Department of Public Safety,  
Alcohol & Gambling Enforcement Division

- Certificates only (binders or declarations are not accepted)
- "Insured" name must match "licensee" name
- Must have physical address of establishment listed
- Must have the term "liquor liability" stated on certificate
- Policy dates must completely cover the licensing period or state "continuous until canceled"

### \*Liquor Liability (per occurrence)

- \$50,000 one person, \$100,000 2+persons Bodily Injury
- \$10,000 Destruction of Property
- \$50,000 one person, \$100,000 2+ persons Loss of Means of Support
- \$50,000 one person, \$100,000 2+ persons Pecuniary Loss
