# 2026 ENERGY STAR Appliance Rebate Instructions

By participating in the We Save program, you can save energy and earn a rebate when you purchase a new ENERGY STAR® certified appliance or recycle a full size, operating refrigerator or freezer.

## What rebate can I earn?

**\$25 Rebate:** Refrigerator, Freezer, Dishwasher, Clothes Washer, Electric Clothes Dryer, Dehumidifier, Air Purifier

**\$50 Rebate:** Recycling Bonus (Refrigerator or Freezer)

## What does it mean to be ENERGY STAR Certified?

- **ENERGY STAR certified appliances have an ENERGY STAR logo on their yellow EnergyGuide label and can use much less energy. For example:**
- Refrigerators are 9% more efficient than regular models and 30% more efficient than older models.
- Freezers are at least 10% more efficient than regular models.
- Dishwashers use less electricity and water than regular models, saving an average of over 5,800 gallons of water over the lifetime of the unit.
- Clothes washers use 20% less energy and 30% less water than regular models.
- Electric clothes dryers use 20% less energy than regular models.
- Dehumidifiers use 13% less energy than regular models.
- Air purifiers are over 25% more efficient than regular models.

## Rebate Qualifications and Program Rules

- Residential customers receiving electric service from the City of Le Sueur are eligible for rebates when they purchase ENERGY STAR certified appliances.
- Rebate will be issued to the customer only. Rebate shall not exceed 50% of price paid.
- Appliance rebate forms must include: (1) Rebate Application, (2) dated sales receipt, and (3) EnergyGuide label with ENERGY STAR logo (not required for dehumidifiers, clothes dryers, and air purifiers). Incomplete rebate applications will not be processed.
- Recycling Bonus is for full-size units and rebate forms must include: (1) Rebate Application and (2) Proof of recycling
- Proof of recycling is met with receipt specifying removed appliance was recycled or Proof of Recycling Certificate.
- **Appliances must be on ENERGY STAR list at time of purchase. If unsure, ask your retailer to confirm.**
- **To qualify for Recycling Bonus rebate, unit must be a secondary unit, in operating condition prior to removal, and proof of recycling must be provided.**
- Information on Rebate Application must match invoice.
- Customer must apply for rebate within one year of the purchase date shown on the sales receipt.
- Limit one rebate per appliance per customer account per year.
- Rebate requests are processed on a first-come first-serve basis. Annual rebate funds are limited. Rebate programs, qualifications, and amounts are subject to change at any time.
- Qualifying customers must apply for rebate by November 30, 2026.

If you are also applying for the Recycling Bonus Rebate, please attach a copy of the Recycling Bonus Rebate Application and necessary documentation.

- Receipt specifying removed appliance was recycled
- Proof of Recycling Certificate (provided by retailer)
